1 Rules

The event will be governed by the *rules* as defined in *The Racing Rules of Sailing*.

2 Eligibility

- 2.1 This regatta is open to all R&D Thistle Class boats that possess a valid measurement certificate.
- 2.2 Current membership in the TCA is required for all skippers.
- 2.3 Eligible boats may register by completing the Entry Form and mailing it, together with the entry fee, to Karen Dexter; 610 Maxwell Place; Ridgewood, NJ 07450

3 Fees

- 3.1 Entry fee includes three dinners Saturday night:
 - \$110 per boat for members of US SAILING
 - \$120 per boat for non-members of US SAILING
- 3.2 Late fee for entries received after June 19, 2010: \$15

- 1200 Warning Signal for first race, multiple races to follow

Sunday, June 27, 2010

- 1000 Warning Signal for first race, multiple races to follow
- 1330 No warning after this time

5 Sailing Instructions

Sailing Instructions will be available at registration and may be available earlier on the Nyack Boat Club web site.

6 Venue

The racing area will be that part of the Hudson River known as the Tappan Zee; south of the point of Hook Mountain and north of the Tappan Zee Bridge.

7 Scoring

- 7.1 The scoring system will be the low point scoring system of Appendix A, except that no score will be excluded.
- 7.2 Multiple races are scheduled. One race constitutes a regatta.

8 Prizes

Prizes will be awarded to the top five competitors.

9 Disclaimer of Liability

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
