

## Notice of Race

### 2010 Central Atlantic District Championship Regatta June 12 & 13, 2010

Hosted By: Thistle Fleet 34 and Severn Sailing Association  
Annapolis, MD.

**Rules:** This regatta will be governed by rules as defined by the Racing Rules of Sailing, the prescriptions of the Thistle Class Association (TCA), this Notice of Regatta, and the Sailing Instructions.

Racing rules will be changed as follows: Appendix A 2, all races scored; Signals AP, changes time when signaled on shore; and 61.1(a), notify race committee boat of protest. These changes will appear in full in the Sailing Instructions.

**Eligibility and Entry:** This regatta is open to all Central Atlantic District R&D Thistle Class boats. Current Active membership in the TCA is required for all skippers and a current Registration is required for all boats.

**Fees and Registration: Regatta Entry Fee:** \$25 U.S. Sailing Association members; \$30 non-members. **Late Registration Fee: \$10 (If payment received AFTER June 7, 2010).**

Safety equipment required by the TCA will be checked – PFDs, throwable, whistle, anchor, paddle, bailing device.

**Racing Area:** The racing area will be in the Chesapeake Bay, north of the mouth of the Severn River.

**Courses:** The courses to be sailed will be described in the Sailing Instructions

**Scoring:** The Low Point Scoring System, Appendix A of the RRS will be used. There will be no “throw-outs”. Five races are scheduled, of which one shall be completed to constitute a regatta.

**Prizes:** Prizes will be awarded to the top 5 competitors.

**Disclaimer of Liability:** Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
